Sub : Police Estt- Seniority Dispute between directly recruited AR personnel and AP Bn Personnel – stagnation in promotion - filling up of SCPO/CPO vacancies in district -Orders issued- reg.

Ref : 1. Minutes of the meeting conducted at Police Headquarters on 07/02/2018 under the chairmanship of Sri. S. Ananthakrishnan IPS ADGP(HQ).

2. PHQ endt. No. E4-16312/2018/PHQ dated 16.2.2018.

3. Message No. A1/1/2018/TSR dated 06-03-2018 of IGP, Range Office Thrissur.

The seniority disputes between AP Battalion personnel and directly recruited District AR Personnel has resulted into stagnation of promotion in the cadre of SIs/ASIs/SCPOs in the Kerala Police Wing. The matter is now under consideration of the Hon'ble High Court Kerala. The deadlock in promotions also blocked the recruitment of CPOs.

A meeting of the Range Level Officers was conducted at PHQ on 7.2.2018 to discuss about the stagnation in promotion in the cadre of SIs/ASIs/SCPOs as a result of the seniority dispute between AP Bn Personnel and directly recruited AR personnel, and also about various problems related to the issues. In order to overcome the present situation the following actions are recommended.

1. The regular vacancies of SCPOs, if any remaining in the districts has to be filled up immediately by observing the rules and procedure.

2.The resultant vacancies in the cadre of SCPOs in the district as detailed below has to be calculated.

3. The eligible CPOs from the select list has to be promoted to the cadre of SCPOs on a temporary basis against the notional SCPO vacancy calculated as above.

4. The resultant vacancies of the CPOs in districts has to be evaluated and reported to ADGP (APBn) for KCP transfer from Battalions.

Based on that Range office message in the reference cited had directed to give temporary promotion to CPOs as SCPOs in the above vacancies by following the above directions.

In pursuance of the above orders, the vacancies of promotee SIs and ASIs in the Malappuram district has been calculated. A total number of 92 notional SCPO vacancies are existing in this district. As such the following eligible CPOs whose names are included in the select list of CPOs fit for promotion as SCPOs are temporarily promoted to the cadre as Senior Civil Police Officers in the scale of pay of Rupees 27800 - 59400 with immediate effect against the existing vacancies of SCPOs/ASIs/ 50% of the vacancies of SIs by considering the administrative exigencies

and allotted to the unit/station noted against each. The promotion will take effect from the date of charge taken as SCPO in the unit posted.

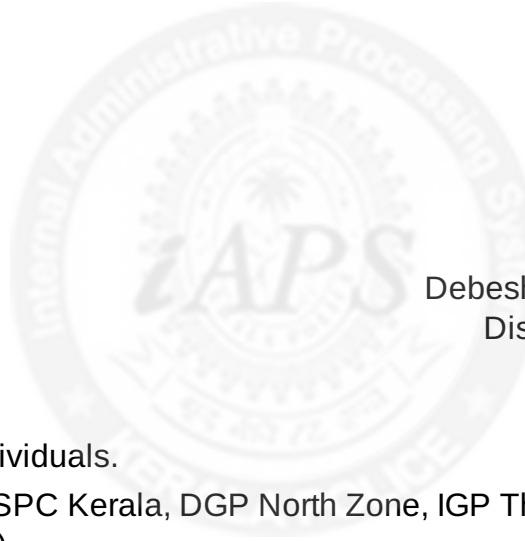
