Sub : Police Estt. - Designation of WCPO as Grade Senior WCPO– Orders issued – Reg.

In pursuance of orders issued in the references cited, Smt.Rekhamol.K.C WCPO 3837 MM is designated as Grade Senior WCPO with immediate effect subject to the following conditions as per PHQ Circular cited 2nd.

Grade Senior Woman Civil Police Officer : A Woman Civil Police officer will be designated as Grade Senior Woman Civil Police officer by the unit head concerned as per the Govt. Orders cited above and this will be subject to the following conditions.

1) The Woman Civil Police Officer must have completed 15 years of service including the training period.

2) The period of LWA taken for employment abroad, suspension period not regularized as duty for increment will not be reckoned as qualifying service for sanctioning Grade designation.

3) The Woman Civil Police Officer will be working in the Local Police / AR.

4) The Woman Civil Police Officer to be designated as Grade Senior Woman Civil Police Officer should have passed the mandatory Head Constable test and should be eligible for promotion as regular Woman Senior Civil Police Officer.

5) She should be drawing pay in the pay scale equal to or higher than that of a Senior Woman Civil Police Officer.

6) The Woman Civil Police Officer to be designated as 'Grade Senior Woman Civil Police Officer' will be promoted to the cadre of Senior Woman Civil Police Officer and when her turn comes in the regular line of promotion, unless she is found eligible an only on the basis of the seniority list and on the recommendation of the departmental promotion board.

7) The 'Grade Senior Woman Civil Police Officer' will only be the personal rank of the person so designated and she will only occupy the lien of the post of a Woman Civil Police Officer till she gets her regular promotion as Senior Woman Civil Police Officer.

8) The persons designated as 'Grade Senior Woman Civil Police Officer' will be eligible to wear the uniform of the regular Senior Woman Civil Police Officer.

9) These persons will not be eligible for higher pay and allowances other than those

she would have received, if she had not been so designated as 'Grade Senior Woman Civil Police Officer'.

10) The Woman Civil Police Officer designated as Grade Senior Woman Civil Police Officer is authorized to perform all the duties and responsibilities of a regular Senior Woman Civil Police Officer and also is responsible to discharge the duties of a regular Constable.

11) The Grade Senior Woman Civil Police Officer can also held the charge of Station General Diary as Station House Officer, in the absence of regular Station House Officer.

12) The Grade Senior Woman Civil Police Officer is also authorized to investigate the crime cases registered in the Police Station entrusted to her by the Sub Inspector/Inspector (SHO) of the Police Station concerned for investigation.

13) The Woman Civil Police Officer who are designated as Grade Senior Woman Civil Police Officer will not have any claim for seniority in the category of the regular Senior Woman Civil Police Officer by virtue of their designation as Grade Senior Woman Civil Police Officer.

14) The Woman Civil Police Officer who are eligible to be designated as Grade Senior Woman Civil Police Officer and working in the special units will also have to be designated so, by the concerned Dist. SPs/CPs on whose strength such Woman Civil Police Officer are borne.

15) The Woman Civil Police Officer who are designated as Grade Senior Woman Civil Police Officer and are working in the special units are authorized to discharge the duties of a regular Senior Woman Civil Police Officer working in the concerned special unit and is also responsible to discharge of duties of a regular Woman Civil Police Officer of that special unit.

16) The Woman Civil Police Officer who is designated as Grade Senior Woman Civil Police Officer cannot claim any posting in any unit against the vacancy of a regular Senior Woman Civil Police officer.

17) The Woman Civil Police Officer who is designated as Grade Senior Woman Civil Police Officer will still be occupying the lien of a Woman Civil Police Officer and there will not be any right or claim for any other Woman Civil Police Officer for posting against that particular Woman Police Civil Police Officer post.
