In pursuance of Orders issued in the reference cited, the following Police Personnel are designated as ASI Grade Driver with immediate effect subject to the following conditions as specified in the reference cited.

**Assistant Sub Inspector Grade Driver**

1) He must have completed 22 years of service including basic training period. The eligible service is the service reckoned excluding the punishment of reduction of Rank, foreign service on LWA to take up employment abroad and period of suspension which is not treated as service for the purpose of sanctioning increment. But those who have departmental disciplinary proceedings under Kerala Police Departmental inquiries, Punishment and Appeal Rules pending against them or are included in the array of an accused in any criminal cases, which have occurred during the course of their duty will not be eligible for the Grade Designation.

2) He must be drawing a pay scale equal to or higher than that of a Asst. Sub Inspector Driver.

3) He cannot claim seniority based on these grade promotions and will consider for their next regular promotion as and when their turn comes unless found ineligible.

4) Asst. Sub Inspector Grade Driver will be the Personal Rank of such person so designated and he will be eligible to wear the uniform of Asst. Sub Inspector Driver of Police

5) He will not be eligible for higher pay and allowances other than what he would have been received had they not been designated as Asst. Sub Inspector of Police Grade.

6) He will be accommodated among the available sanctioned posts in the rank of Senior Driver Civil Police Officers.

7) He has to carry out the duties he is entrusted with in the rank of SCPO Driver .
