In pursuance of Orders issued in the references cited, the following Police Personnel of Technical Category (Driver/Armourer) are designated as Asst. Sub Inspector (G) Driver/Armourer with immediate effect subject to the following conditions as specified in the references cited.

Asst. Sub Inspector (Grade) Driver/Electrician

1) He must have completed 20 years of service including basic training period. The eligible service is the service reckoned excluding the punishment of reduction of Rank, foreign service on LWA to take up employment abroad and period of suspension which is not treated as service for the purpose of sanctioning increment. But those who have departmental disciplinary proceedings under Kerala Police Departmental inquiries, Punishment and Appeal Rules pending against them or are included in the array of an accused in any criminal cases, will not be eligible for the Grade Designation.

2) He must be drawing a pay scale equal to or higher than that of a Asst. Sub Inspector.

3) He can not claim seniority based on these grade promotions and will consider for their next regular promotion as and when their turn comes unless found ineligible.

4) Asst. Sub Inspector (Grade) will be the Personal Rank of such person so designated and he will be eligible to wear the uniform of Asst. Sub Inspector of Police.

5) He will not be eligible for higher pay and allowances other than what he would have been received had they not been designated as Asst. Sub Inspector of Police (Grade).

7) He has to carry out the duties he is entrusted with in the rank of SCPO/SCPO G

Hence the following Police Personnel of Technical Category (Driver/Armourer) are designated as Asst. Sub Inspector (Grade) Driver/Armourer with immediate effect vide details shown below.
