Order No : A3-70550/2019/MM(1) Dated. 21-01-2020

In view of the final Order dated 07.08.19 of the Hon'ble High Court of Kerala in OP(KAT) No.506/2017, as per the directions issued vide read 2nd & 3rd cited, In order to resolve the long pending seniority dispute between PCs recruited into the Police force through Armed Police Battalions and District Armed Reserves who were recruited as per Special Rules Government had issued GO(P)28/2017/Home dated16/02/2017 by making an amendment in Special Rules vide of GO(MS) No.33/89/Home dated10.03.1989, to protect the advice seniority of PCs who were recruited in Battalion and later transferred to District Armed Reserve. Against the Government order some Police personnel moved to the KAT. The Hon'ble KAT in the Orders dated 14/12/2017, declared that giving retrospective effect to the amendment from 17.07.1986 as per GO(P)28/2017/Home, dated 16/02/2017 is unconstitutional and violation of Articles 14 and 16 of the Constitution of India.

Aggrieved with the order of the Kerala Administrative Tribunal some personnel moved appeal before the Hon'ble High Court of Kerala vide OP(KAT) No.506/2017. Hon'ble High Court of Kerala in OP(KAT) No.506/2017 dated 07.08.19 set aside the order of the Kerala Administrative Tribunal and uphold the retrospective effect of amendment made in Special Rules. As such the order of the Government vide reference 7th cited stands exists.

Accordingly finalised Seniority list of AR Police Constables as on 31.03.2010 was published as per order read as 11 above. In continuation to the above a provisional seniority list of AR Head Constables of this unit from 01.01.1990 to 31.03.2010 is published herewith for communication among the concerned.
