As per the Government Order cited 1st, which is a clarification to section 88(2) of the Kerala Police Act 2011 which having effect from 31/01/2011 (the date of notification of Police Act), the period of training including examination and extended period of training if any, shall be treated as officiating service for the purpose of probation, increment and pension on completion of training.

The period of training including examination and extended period of training if any, had already been counting for sanctioning of annual increment in the case of Police personnel appointed on or after 31/01/2011 but had not been counting for declaration of probation. Since it is clarified that the above period can also be counted for probation, the declaration of probation in respect of the following Police Personnel was revised vide reference cited (2)

Consequently, the monetary benefit of second increment and in certain cases third increment in respect of the following Civil Police Officers is revised as furnished below.
